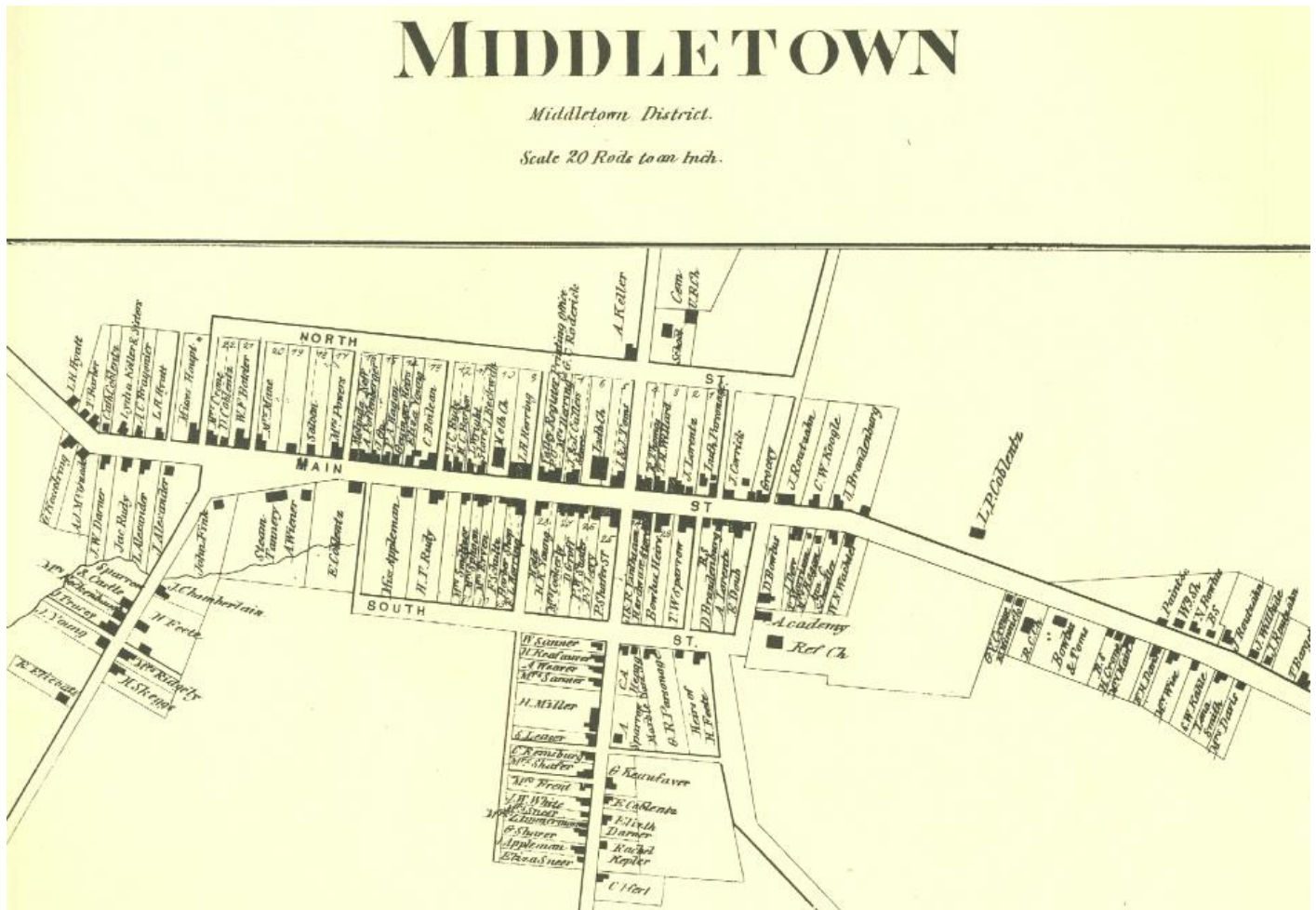

Introduction

Middletown Maryland was part of the tract Smithfield patented to Richard Smith in 1750. Richard Smith was indebted to Josiah Beall at the time of his death. In 1766 (Deed K-662) Josiah Beall deeded the 44 acres of land to Michael Jesserong. On March 6, 1767 Michael Jesserong (Tavern Keeper) deeded the first lot to Peter Brown. Michael Jesserong sold the tract Smithfield with ground rents to Conrad Croun/Crown/Crone on August 15, 1768 (Deed L-397). Conrad Crone died in 1808 and in his will left the Middletown lots and ground rents to his daughter Margaret Crone.

Middletown consisted of 32 lots with each measuring 66' x 330'. No plat of Middletown in 1767 has been located. The earliest known plat is the H.G. O'Neal 1829 plat located in Frederick County Levy Court (Road Record 1825-1845 Folio 24).
