



Collington Manor (3000 Acres) is located near Mitchellville. When Collington Manor was first surveyed and who the tenants were is unknown. The earliest mention of the manor and its courses was located in Maryland State Archives Division Plat SE34-128 for the year 1755. In Prince Georges County Unpatented Certificate 92 Collington Manor (No date listed) includes a survey showing the lots within the manor. Prior to the 1755 survey information in the Division Plat, three parcels of land were patented for the year 1683, 1698 and 1709. These tracts were resurveyed into new tracts from 1759-1819.
